RE: July 2011 Drug Test Statistics (Adult Arrestees)

Drug testing of adult arrestees for July 2011 revealed an overall positive test rate of 33% consistent with June 2011. Cocaine revealed a 2% increase and opiates revealed a 1% decrease; multi-positives, amphetamines and PCP remained consistent with June 2011.

The breakdown of July 2011 test results is as follows:


